## **OBJECTION TO SECOND MOTION FOR CONTINUANCE**

TO THE HONORABLE JUDGE OF SAID COURT:

NOW COME James E. Basham and Jenny L. Basham, Plaintiffs herein, with their Objection to Second Motion for Continuance of Hearing scheduled for October 23, 2025 filed on September 29, 2025. Petitioners object to the Respondent's Second Motion for Continuance of Hearing for 30 days.

Respondent's Second Motion for Continuance of Hearing refers to a Motion not filed by Petitioners.

Petitioners filed Motion to Show Authority, not Motion to Enforce.

Respondent's Second Motion for Continuance of Hearing refers to a filing date of August 5, 2024. Petitioners filed Motion to Show Authority on July 21, 2025. The initial Petition was filed on June 25, 2025. Petitioners have no case filed prior to June 25, 2025 involving Respondent and therefore, have no filings dated August 5, 2024.

Though Mr. Bishop's first Motion for Continuance filed on September 15, 2025 was due to medical reasons, he was advised on September 2, 2025 by his medical staff not to drive; however, Mr. Bishop did not request a continuance until September 15, 2025, less than 24 hours prior to the hearing date of September 16, 2025. Mr. Bishop's actions did not provide Petitioners a respectful period of time to make necessary schedule changes to accommodate the change.

Mr. Bishop stated in his Motion for Continuance of Hearing filed on September 15, 2025 he has surgery scheduled for November 12, 2025. A Continuance for another 30 days from the date previously set by this Court of October 23, 2025, Petitioners believe the probability of a third Continuance request by Mr. Bishop is high due to his scheduled surgery.

The initial Petition filed on June 25, 2025 is for Access to Property Owners Association Public Record Upon Denial of Access. Mr. Bishop's repeated requests for 30 days Continuances has caused and will continue to cause delays in Petitioners rights to obtain records under the Texas Residential Property Owners Act. Petitioners are prepared to present evidence of Mr. Bishop's lack of authority to defend a case blocking these rights to the Court.

WHEREFORE, PREMISES CONSIDERED, Petitioners object to the Respondent's Second Motion for Continuance of Hearing for 30 days. Petitioners request the Court order Mr. Bishop to present proof of his authority to this Court to allow the case to move forward without further delays. Alternatively, should the Court approve Mr. Bishop's request for a Continuance and reset the hearing scheduled on October 23, 2025, Petitioners respectfully ask the Court to reschedule the Motion to Show Authority Hearing prior to Mr. Bishop's surgery scheduled on November 12, 2025.
